This issue was discussed under C/Agenda(19)02, item 13, in the ISO Council meeting of 29 November 2019. The timetables below have been amended in accordance with ISC-Decisions-56 — no.14 and progress made in subsequent Administrative Committee meetings on 28 February and 24 April 2020.

NEGOTIATIONS FOR A PARTIAL REVIEW OF ISA, 1992

At their meeting of 19 July 2019 Council decided (ISC-Decisions-55 – no.5):

"to open negotiations before the next Council meeting in November 2019, under UNCTAD guidance. This would be for a partial review of ISA, 1992 – focusing on Chapter I and Chapter VII, specifically in relation to matters of "administrative budget and contributions of Members", as well as other limited amendments including Chapter IX and Chapter X that Members chose to bring forward. This process must be completed before 31 December 2021."

It is proposed that the Administrative Committee oversees the negotiation process on behalf of Members and makes recommendations to Council. The Administrative Committee consists of the 10 largest Members and 8 elected Members so should be representative of the entire membership. Members who are not on the Committee are invited to attend and participate in discussions, and the evolution of a "Negotiating Group" should be considered.

To facilitate this process, it is recommended that the Administrative Committee meets for at least 4 times for the next two years. The dates proposed in Appendix I have been approved.

It is assumed that Members seek reform of the existing agreement (ISA, 1992) to be enacted under article 44 rather than to renegotiate a completely new agreement under article 35. Appendix II contains a flowchart showing the key decisions required. It should be noted that regardless of what process is followed a decision whether to extend ISA, 1992 will be required by 31 December 2021.

There would be two phases in this process:

- phase I will be to negotiate and agree any amendments proposed by Members (see below)
- phase II will be the schedule required to complete the procedures required under article 44 by the date Members establish as result of the COVID-19 pandemic (Appendix III).


These timetables are the first items relating to the renegotiation process requiring to be agreed or amended by the Administrative Committee.

Article 44 of the ISA 1992 permits amendments to be made to the Agreement and specifies the requirements for such an amendment to be incorporated into ISA 1992. However, the Agreement does not specify the procedures to be followed to table the amendment and there is no process defined within the Administrative Rules, so the following timeline is proposed.

The wording of Article 44 of ISA 1992 is reproduced below.

Article 44 - Amendment

- 1. The Council may, by special vote, recommend to the Members an amendment of this Agreement. The Council may fix a time after which each Member shall notify the depositary of its acceptance of the amendment. The amendment shall become effective 100 days after the depositary has received notifications of acceptance from Members holding at least two thirds of the total votes of all Members under article 11 as determined under article 25, or on such later date as the Council may have determined by special vote. The Council may fix a time within which each Member shall notify the depositary of its acceptance of the amendment and, if the amendment has not become effective by such time, it shall be considered withdrawn. The Council shall provide the depositary with the information necessary to determine whether the notifications of acceptance received are sufficient to make the amendment effective.
- 2. Any Member on behalf of which notification of acceptance of an amendment has not been made by the date on which such amendment becomes effective shall, as of that date, cease to be Party to this Agreement, unless such Member has satisfied the Council that acceptance could not be secured in time owing to difficulties in completing its constitutional procedures and the Council decides to extend for such Member the period fixed for acceptance. Such Member shall not be bound by the amendment before it has notified its acceptance thereof.

Article 2 - Definitions

For the purpose of this Agreement:

4. "Special vote" means a vote requiring at least two thirds of the votes cast by Members present and voting, on condition that these votes are cast by at least two thirds of the number of Members present and voting;
