The Executive Director/Secretariat wishes to suggest to Members that they use the date of the Next Council Meeting, 24 November 2023, as a soft deadline for obtaining approval of the amendments according to their constitutional procedures, in order that Council can take note of the most significant progress possible in consolidating the reforms to the 1992 ISA.

WHEREAS the amendments to articles 1, 23(1), 25, 32, 33 and 34 of the **International Sugar Agreement, 1992** were approved in London on 26 November 2021, by Members of the International Sugar Council (ISC-Decisions-59, Item 12) for consideration and approval by Member governments.
