#### US: Consumers still ruled by taste even if they think they should cut sugar

Consumers may be focused on sugar in their attempt at living healthy, but taste remains the primary factor influencing buying decisions, while confusion also reigns, speakers said on Aug. 7 at the International Sweetener Symposium, sponsored by the American Sugar Alliance, which represents sugar beet and cane growers, processors and refiners, according to the US's Food Business News. Lynn Dornblaser, director of innovation and insight at Mintel Ltd., said that in the concept of health and w...

#### ECRUU Sugar News Monitor - 9 August 2018 WORLD - Sugar content does not influence food purchases: experts

Studies suggest that taste remains the most important factors when people buy food, much more than healthiness, according to a Mintel expert. She added that when consumers look for healthy products, the sugar content matters less than freshness, as consumers are increasingly focusing on natural and organic food, instead of processed food. She urged sugar producers to better communicate with consumers to counter misinformation and understand their preferences.

In Britain, meanwhile, a survey found that 62% of consumers made no change in their purchasing behaviour after a levy was introduced on sugar-sweetened beverages. Only 1% of the surveyed stopped buying soft drinks after the tax, compared to 11% who planned to give up soda drinks before the tax was imposed. But a Nielsen official noted that beverage makers have been cutting down on added sugar so that most sweetened beverages do not attract the tax. (Food Business News & Talking Retail)
