• Cofco International CEO Johnny Chi Is Said to Be Chairman – Bloomberg – Cofco International Ltd. Chief Executive Officer Jingtao "Johnny" Chi will become chairman of the global trading arm of China's biggest food company, according to people familiar with the matter. Chi will move from Geneva to Beijing and take the chairman role by the end of the year. Dong Wei, chairman and executive director of China Agri-Industries Holdings Ltd., another subsidiary of Cofco International's parent Cofco Corp., will be CEO, the people said. The reshuffling of two powerful executives within the Cofco empire show the company remains set on creating a major agricultural trading house, while also securing food supplies for the world's most populous country.
