#### **ARGENTINA: Senator suggests bill to support sugarcane sector**

Argentinian senator Silvia Eliás, representing the Tucumán province, has presented a bill in Congress suggesting measures to help the country's sugarcane production chain by declaring an economic emergency in the sector, according to Portal Caña news website.

The bill includes rules to allow the extension of tax payments deadlines and overdue social security obligations for the sugarcane sector in Tucumán, Santa, Jujuy, Santa Fe and Misiones provinces.

The sugarcane sector in Tucumán generates about 60,000 indirect and direct jobs.

The bill was also signed by Jujuy senators Mario Flad and Silvia Giacoppo.

The president of Argentina's Sugarcane Chamber, Jorge Rocchia Ferro, said that some challenges faced by the sector are interest rates and the concentration of incentives only in the central region.

Sugarcane production is one of the most important economic activities in the north of Argentina.

## ECRUU Sugar News Monitor - 24 July 2019 UNITED STATES - Coke, Pepsi cash in on healthy trend

Coca-Cola reported net revenues of USD 10 billion in Q2, up 6.1% thanks to a 4% volume growth. The CEO said the strong performance was thanks to a growing demand for their no-sugar drinks and smaller packages. Reformulated and new products now bring in a quarter of the group's revenues, from 15% in 2017. Similarly, sales of healthy snacks, sparkling water and smaller packaging helped Pepsi's net income increased to USD 2.04 billion in Q2, from USD 1.82 billion in the same period last year.
