UK: Study suggests sugar beet cultivation in Scotland to help reduce GHG emissions

Planting sugar beet crops in Scotland to produce ethanol and new plant-based biotech products could help the country meet greenhouse gas reduction targets, has shown a recent study, according to UK's Farmers Weekly.

The study was produced last year by consultants NNFCC for Scottish Enterprise and has called the attention of a Rural Innovation Support Service group, which is looking into the feasibility and steps required to re-establish the sugar beet crop and processing in eastern Scotland.

Scottish farmers haven't produced sugar beets for almost 50 years. Resuming production would be an opportunity to contribute to reducing CO2 emissions, but farmers will have to factor the risks and rewards of growing a new crop, according to the report.

BRAZIL: Sao Martinho looks at corn as ethanol source

Brazil's Sao Martinho mill is considering using corn alongside sugar cane to boost its ethanol production it said on Feb 11, according to Reuters.

This system allows plants to use cane waste as an energy source to process the corn and expand the production period to a full year, instead of just during the cane crop from April to December.

"It is a project under evaluation. Logistics is an important issue, since we would have to bring corn from the center-west," said Felipe Vicchiato, Sao Martinho's chief financial officer.

Sao Martinho is already building an attached installation to produce ethanol from corn at its Boa Vista mill, located in Quirinopolis, Goias state.
